During the many years spent working on the mediation procedure and the Vienna Airport Dialogue Forum, many measures – i.e. regulation governing night flights, noise protection programme, air route changes and many more – to reduce the negative impact of air traffic were agreed between the air traffic industry, local communities and the population. Many have already been implemented and a level of protection, which is considerably better than the minimum requirements defined in legislation, has been achieved for those living in the Vienna Airport region.

At the Dialogue Forum, compliance with the agreement terms is verified. In addition, further measures are being developed to minimise the negative impact of air traffic as far as possible without hampering the airport region's dynamic development.

Citizens' initiative against aircraft noise (ARGE gegen Fluglärm) –

We work for environmental quality and to minimise the negative impact of air traffic

At the Dialogue Forum, over two million people from around 130 municipalities and three federal states have the opportunity via representatives to talk with state, municipality and aircraft industry representatives. The working group against aircraft noise, an association of 14 citizens' initiatives and resident associations who are active in the Dialogue Forum, has many with the same concerns, issues and worries.

At the Dialogue Forum, the most divergent interests are dealt with on an equal footing. The citizens' initiative against aircraft noise understands people's concerns regarding the quality of life and environmental quality in the airport region. It also listens to their concerns relating to the effects of air traffic.

The citizens' initiative against aircraft noise analyses and assesses the effects of air traffic on people and the environment with the help of air traffic experts. Furthermore, it continuously negotiates other concrete measures against the negative impact of air traffic.

The citizens' initiatives have already implemented many measures against air traffic pollution with the neighboring communities. However, the residents will be affected by the effects of the 2-runway system for a longer period of time, which is why we have entered into intensive negotiations to further reduce aircraft noise and pollution through new measures for the benefit of the citizens.«
